ANNEX: 3 Technical Programme Details

Working Sessions

Work sessions run from 09:00 to 16:30

All sessions will be in 45 minutes modules, except plenaries that will be 1 hour.

- In general, speakers are given 15 minutes in plenary sessions and 10 minutes in parallel sessions for their presentations to allow time for discussion.
- Some sessions will consist of a panel of experts (no presentation) with open discussion.
- Pre-conference workshops will be conducted as instructional lessons. Workshops will be allotted in 45 minutes slots.
- Posters will be displayed on Saturday and Sunday 23-24 November, with time for presentation and discussion during special poster sessions and also during the breaks.
- There will also be an exhibition area on Saturday and Sunday 23-24 November. Commercial branding will not be allowed.

Electronic Conferencing

In order to promote effective interaction, electronic conferencing as used in the First Global Forum on Medical Devices will be available.

- The software will allow participants to interact, ask questions, vote, recommend, keep track of the agenda, retrieve information from posters, and to identify and connect to other participants.
- For those who agreed to use their own personal iPhone or Android device, a link to the conferencing application will be sent a few days prior to the forum. Please ensure that the application has been uploaded to the phone that it is brought to the event.
- For those who do not have their own personal device, there will be a few made available. However, we highly encourage that if you have your own device to please bring it to facilitate the process.
- The information collected at the forum can be retrieved within the application and it will remain available on the web for one year.

Translation

The general language will be English.

- The plenary sessions that will take place on Saturday and Sunday 23-24 November will be translated to French and Spanish.
- Certain parallel sessions on Saturday and Sunday 23-24 November will be translated either into French or Spanish. The language of translation, if available, will be clearly noted in the Final Programme.
- Workshops on Friday 22 November will be conducted in different languages but no translation of the workshops will be available. The language of the workshop will be clearly noted in the Final Programme.

We are pleased to provide you with the following information regarding the practical arrangements for the above forum.

- 1. Venue of the meeting: **International Conference Center (CICG).**Address: Rue de Varembé 17, 1211 Geneva, Switzerland. http://www.cicg.ch/en/
- 2. Work sessions: **From 9:00 am to 4:30 pm.**Two thirty minutes breaks will occur around 10:00 am and 3:30 pm.
- 3. Food: you will be given about one and a half hour to go to lunch. Please note that no food will be provided. We recommend you have breakfast at your hotel, and then for breaks or lunch to go to the CICG restaurant in the venue, which has economic prices for beverages and food packages for you to purchase (meals around 10 CHF and 20 CHF).
- 4. Local currency is **Swiss Francs (CHF) not Euros.** Exchange rate is around US \$ 0.93.
- 5. Accommodation: For Geneva information, you may visit the official website http://www.ville-geneve.ch/welcome-geneva/

Please note that the payment of your hotel room is your own responsibility.

Note: All hotels in Geneva will provide a free transportation card for bus, tram, train, or even boat for the duration of your stay.

6. Visa: please note that it is your responsibility to obtain any vaccinations and visas which may be necessary for this travel. In this regard please verify with the nearest Swiss Embassy or consulate whether you are required to have a visa to enter Switzerland, please see: http://www.myswitzerland.com/en-ch/passport-visa.html

If you have already submitted a request for visa through the registration process, WHO will provide you with a visa support letter shortly, which you should present to the competent Swiss representation when applying for a visa. WHO has been informed that visa procedures may take up to 21 days. You are therefore urged to apply for a visa well in advance of your planned departure date. It is understood that the decision whether or not to issue a visa to any applicant rests with the competent Swiss authorities.

7. Local Transportation from Airport to hotel:

<u>Arriving at Cointrin Airport:</u> You will need to arrange your own transport. You may take a train, bus, or taxi.

If taking public transportation (train or bus), make sure to take a FREE ticket inside the baggage claim area. (If you do not take this ticket, you will have to pay for your public transportation).

- -The train and bus cost is 3.50 CHF per hour, (10 CHF for a ticket that you can use for the entire day). Please note that all Geneva hotels will provide you with a free transportation ticket.
- -- Taxi cost is around 35 USD from Airport to Cornavin train station.

Signs to reach the train station, bus stops, and taxi stands are clearly marked. The train and Bus 5 will take you from Airport into the city's main train station: Gare Cornavin. From there, you can either walk to your hotel or take another mode of transport to reach your hotel. Please contact your hotel for details on the best way to arrive.

8. Arriving at the CICG (conference venue)

Near all pre-booked hotels (except Ibis Nations), you have the tram 15, direction to United Nations, last stop. Other buses (8) take stop UIT and follow signs to CICG. While at the United Nations place, you need to go to your left (not in direction of the Palais des Nations), cross the street and walk down Rue de Varembe to reach the CICG (about 3 minutes). - 9. Other important information:
 - 9.1: It is important that you always carry your passport with you for identification purposes.
 - 9.2: Weather: November is cold so make sure to bring a good jacket/coat.

 Temperature is around 10° C or less. Snow is possible. Check the weather forecast.
 - 9.3: Official language in Geneva is French, but the UN Organizations use mainly English.
